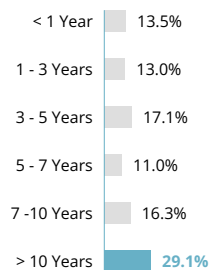

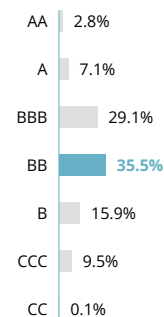

MATURITY BREAKDOWN



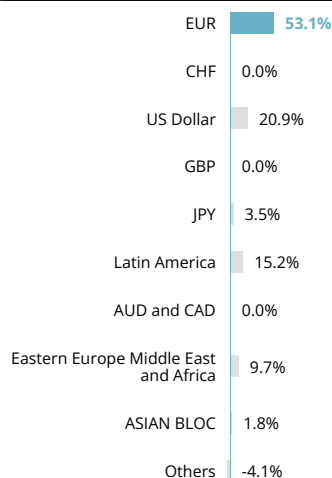

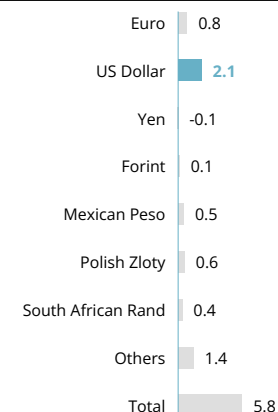

NET CURRENCY EXPOSURE OF THE FUND



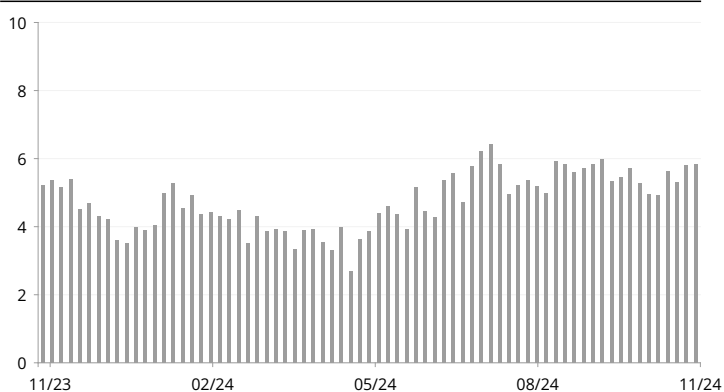
MODIFIED DURATION BY YIELD CURVE (IN BPS)

FUND MANAGEMENT ANALYSIS



MARKET ENVIRONMENT

- November was marked by the election of Donald Trump as President of the United States for the next 4 years, with the Republicans also gaining control of the Senate and the House of Representatives.
- On the central bankers' front, we can point to a second cut in the US key rate of -25bp despite stagnating inflation at +2.6% year-on-year and +3.3% on the underlying component of consumer price indices.
- Despite an environment of strong growth and resurgent inflation, yields fell on both sides of the Atlantic this month, following the example of the US 10-year (-12bp) and the German 10-year (-30bp), notably after the election of Scott Bessent as future US Treasury Secretary.
- Against this backdrop, emerging market assets were mixed: local EM bonds (in local currency) fell back, while external EM bonds (in hard currency) performed well.
- Brazilian assets fell in the wake of fiscal announcements that disappointed investors, with a spending cut of BRL 70 billion over the next two years (0.3% of GDP per year), against BRL 40 to 70 billion loss in tax revenues due to income tax exemptions.
- On the currency front, the US dollar continued to strengthen following Trump's victory in the US elections, weighing on emerging market currencies.



PERFORMANCE COMMENTARY

- With interest rates easing across the board and risky assets performing well, the Fund posted a positive performance, outperforming its reference indicator, benefiting from its main performance drivers with high duration over the period.
- On the rates front, our positions on US rates as well South African, Mexican and Polish local bonds had a positive impact.
- On the credit front, our selection of EM external bonds, notably Argentina and Egypt, had a positive impact, slightly offset by our protective measures aimed at reducing our exposure to this market.
- Finally, on the currency front, we benefited from our exposure to the US dollar, while our positions in the Brazilian real and Indonesian rupiah had a negative impact.



OUTLOOK AND INVESTMENT STRATEGY

- Against this backdrop of a soft landing, with the US economy remaining resilient and inflation continuing its gradual decline, central banks are likely to maintain their accommodating policies. We therefore maintain a relatively high level of modified duration, at around 6 at the end of the period.
- In terms of interest rates, we favor real rates and a steepening strategy in the United States. We are also focusing on central banks lagging the cycle, such as Mexico, Poland or Indonesia.
- On the credit front, we maintain our positive, albeit cautious, bias due to high valuations, and maintain a substantial level of hedging on Itraxx Xover to protect the portfolio from the risk of widening spreads.
- On the external EM debt front, we continue to favor special situations in countries whose economies are undergoing restructuring or significant improvement (Ivory Coast), and those which we feel are less vulnerable to the Trump risk, such as Argentina.
- Lastly, as regards currencies, we have increased our exposure to the US dollar following D. Trump's election, and we retain limited exposure to emerging market currencies. However, we are diversifying our exposure to less accommodative central bank currencies offering high carry, such as the Brazilian real, the South African rand and the Hungarian forint.

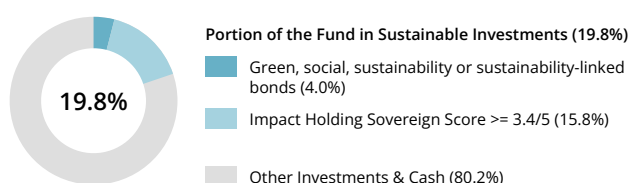
- A minimum of 10% of the Sub-Fund's net assets are invested in emerging market sovereign or quasi sovereign debt issuers within the top quartile of the sustainability score distribution ($\geq 3.4/5$) or green, social, sustainable and sustainability-linked corporate or sovereign bonds;
- Corporate bond Investment universe is actively reduced by at least 20%;
- ESG analysis applied to at least 90% of issuers;
- The minimum levels of sustainable investments with environmental and social objectives are respectively 1% and 1% of the Sub-Fund's net assets;
- At least 60% of its net assets in emerging markets sovereign and quasi-sovereign debt investments respecting the following portfolio composition rules: 60% have a sustainability score of 3 or higher in the scoring system, 90% have a sustainability score of 2.6 or higher in the scoring system, Average exposure weighted sustainability score is above 3.

SUSTAINABLE INVESTMENTS (NET ASSETS)



Our Proprietary **Impact Model Sovereign Score** identifies ESG related risks and opportunities and integrates them in investment decisions. The approach uses objective data from public sources and qualitative adjustments can be performed to reflect recent events not yet factored into the indicators. Numerical scoring system goes from 1 (Bad) to 5 (Good) with 3 as a neutral point for each country.

For the assessment of the **Green, Social, Sustainable and Sustainability-Linked-Bonds**, the Bloomberg sustainable debt indicators are used for screening of company debt securities which have self-reported sustainability features. Considerations such as whether the instrument is classified under recognised market standards (International Capital Markets Association or Climate Bond Initiative) or have third party assurance are important to our assessment.

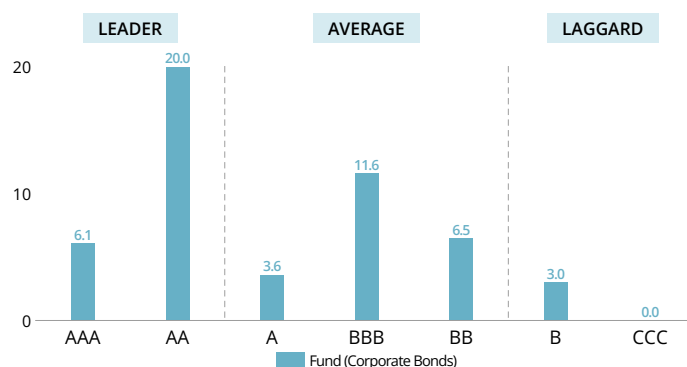

GLOSSARY

Alpha: Alpha measures the performance of a portfolio compared to its reference indicator. Negative alpha means the fund performed less well than its reference indicator (e.g. if the indicator increased by 10% in one year and the fund increased by only 6%, its alpha is -4). Positive alpha means the fund performed better than its reference indicator (e.g. if the indicator increased by 6% in one year and the fund increased by 10%, its alpha is 4).

Beta: Beta measures the relationship between the fluctuations of the net asset values of the fund and the fluctuations of the levels of its reference indicator. Beta of less than 1 indicates that the fund "cushions" the fluctuations of its index (beta = 0.6 means that the fund increases by 6% if the index increases by 10% and decreases by 6% if the index falls by 10%). Beta higher than 1 indicates that the fund "magnifies" the fluctuations of its reference indicator (beta = 1.4 means that the fund increases by 14% when the index increases by 10% but also decreases by 14% when the index decreases by 10%). Beta of less than 0 indicates that the fund reacts inversely to the fluctuations of its reference indicator (beta = -0.6 means that the fund falls by 6% when the index increases by 10% and vice versa).

Capitalisation: A company's stock market value at any given moment. It is obtained by multiplying the number of shares of a company by its stock exchange price.

Duration: A bond's duration is the period beyond which interest rate variations will no longer affect its return. The duration is like a discounted average lifetime of all flows (interest and capital).

High yield: A loan or bond rated below investment grade because of its higher default risk. The return on these securities is generally higher.

Investment grade: A loan or bond that rating agencies have rated AAA to BBB-, generally indicating relatively low default risk.

Investment/net exposure rate: The investment rate constitutes the volume of assets invested expressed as a percentage of the portfolio. Adding the impact of the derivatives to this investment rate results in the net exposure rate, which corresponds to the real percentage of asset exposure to a certain risk. Derivatives can be used to increase the underlying asset's exposure (stimulation) or reduce it (hedging).

Modified duration: A bond's modified duration measures the risk attached to a given change in the interest rate. Modified duration of +2 means that for an instantaneous 1% rate increase, the portfolio's value would drop by 2%.

Net asset value: Price of all units (in an FCP) or shares (in a SICAV).

Rating: The rating measures the creditworthiness of a borrower (bond issuer).

SFDR Fund Classification: Sustainable Finance Disclosure Regulation (SFDR) 2019/2088. EU Act that requires asset managers to classify funds into categories, "Article 8" funds promote environmental and social characteristics, "Article 9" funds have sustainable investments as a measurable objective. In addition to not promoting environmental or social characteristics, "Article 6" funds have no sustainable objectives. Sharpe ratio: The Sharpe ratio measures the excess return over the risk-free rate divided by the standard deviation of this return. It thus shows the marginal return per unit of risk. When it is positive, the higher the Sharpe ratio, the more risk-taking is rewarded. A negative Sharpe ratio does not necessarily mean that the portfolio posted a negative performance, but rather that it performed worse than a risk-free investment.

SICAV: Société d'Investissement à Capital Variable (Open-ended investment company with variable capital)

VaR: Value at Risk (VaR) represents an investor's maximum potential loss on the value of a financial asset portfolio, based on a holding period (20 days) and confidence interval (99%). This potential loss is expressed as a percentage of the portfolio's total assets. It is calculated on the basis of a sample of historical data (over a two-year period).

Volatility: Range of price variation of a security, fund, market or index, which enables the measurement of risk over a given period. It is determined using the standard deviation obtained by calculating the square root of the variance. The variance is obtained by calculating the average deviation from the mean, which is then squared. The greater the volatility, the greater the risk.

Yield to Maturity: Yield to Maturity (YTM) is the estimated annual rate of return expected on a bond if held until maturity and assuming all payments made as scheduled and reinvested at this rate. For perpetual bonds, the next call date is used for computation. Note that the yield shown does not take into account the FX carry and fees and expenses of the portfolio. The portfolio's YTM is the weighted average individual bonds holdings' YTM within the portfolio.

ESG DEFINITIONS & METHODOLOGY

ESG: E for Environment, S for Social, G for Governance

ESG score Calculation: Only the Equity and Corporate Bond holdings of the fund considered. Overall Fund Rating calculated using MSCI Fund ESG Quality Score methodology: excluding cash and non ESG-rated holdings, performing a weighted average of the normalized weights of the holdings and the Industry-Adjusted Score of the holdings, multiplied by (1+Adjustment%) which consists of the weight of positively trending ESG ratings minus the weight of ESG Laggards minus the weight of negatively trending ESG ratings. Principal Adverse Impacts (PAI): Negative, material, or potentially material effects on sustainability factors that result from, worsen, or are directly related to investment choices or advice performed by a legal entity. Examples include GHG emissions and carbon footprint.

Sustainable Investments: The SFDR defines sustainable investment as an investment in an economic activity that contributes to an environmental or social objective, provided that the investment does not significantly harm any environmental or social objective and that the investee companies follow good governance practices.

Taxonomy Alignment: In the context of an individual company, taxonomy alignment is defined as the proportion of a company's revenue that comes from activities that meet certain environmental criteria. In the context of an individual fund or portfolio, alignment is defined as the portfolio-weight weighted average taxonomy alignment of included companies.
